






# 95TH ANNIVERSARY FUND TO SUSTAIN PROGRAMS FOR THE BLIND AND VISUALLY IMPAIRED

Our vision as we begin to look towards our centennial is that every blind and visually impaired person, from blind babies to seniors, has the opportunity to achieve their fullest potential, to wholly participate in all aspects of life, and to stay active and engaged.

For nearly 95 years, Miami Lighthouse for the Blind and Visually Impaired has been transforming the lives of our program participants, from early Intervention for blind babies through seniors affected by uncorrectable vision loss, but the future holds many challenges for this growing population. We must do more to proactively address the growing need. The blind and visually impaired population is increasing exponentially. As a result, many more people need our services: over the past 20 years, our number of program participants has grown from approximately 500 per year to almost 25,000 per year — a 50-fold increase!



To serve the increasing numbers of infants, children, and adults who are blind or have low vision problems, Miami Lighthouse is seeking funds to sustain and grow our programs and build upon our status as a National Center of Excellence in Low Vision and Vision Rehabilitation.

The time has come for Miami Lighthouse to take advantage of its reputation, credibility, fiscal and administrative strength, and past successes to provide much-needed intervention and rehabilitation services to our present and future clients of all ages and ensure sustainability of our existing programs.

The goal of our 95th Anniversary Campaign is to identify initially philanthropists to raise \$4.75 million as the "Matching Challenge Team," with their

one-for-one matching challenge to raise \$4.75 million over two years to generate a total \$9.5 million in recognition of our 95 years of transforming the lives of children and adults. Significant donations will provide naming opportunities such as naming our academy, naming program classrooms, and branding one of our mobile vision units.

#### Ribbon-Cutting Ceremony for New Playground Expansion

On March 22nd, we hosted a Ribbon-Cutting Ceremony in celebration of our playground expansion, the final phase of our Miami Lighthouse Academy multi-year construction project to support the innovative school's classroom growth. Completion of the expanded playground came a year after the opening of the new 30,000-square-foot interior classroom expansion to our existing Academy facility.

The playground features an open field with colorful portable outdoor picnic tables and umbrellas generously funded by former Miami-Dade County Commissioner Rebecca Sosa. Extensive perimeter trees to provide shade were funded in-part by Dixie Landscape and Miami-Dade County Commissioner Raguel Regalado. The entire playground area is protected by a six-foot concrete masonry wall. Sally Heyman, former Miami-Dade County

#### Chairman's Letter

Dear Friends of Miami Lighthouse,

On January 27, 2024, Miami Lighthouse will hold its 95th anniversary celebration. My family and I have been involved with Miami Lighthouse for 35 of those years during which this institution has experienced phenomenal growth. During my first term as Board Chair that began in 2006, Miami Lighthouse had a total of 1,700 program participants compared to nearly 25,000 today, and our physical facility was much smaller with construction of our third-floor addition in progress. Since then, we have added a fourth floor and completed our Miami Lighthouse Academy building expansion.

As our building grew to accommodate the increased demand for our services, new programs were added. For example, in 2007 we acquired our Florida Heiken Children's Vision Program, and in 2021 our Cortical Visual Impairment (CVI) Collaborative opened. In this newsletter you will read touching stories of a young boy who received his first pair of prescription glasses from our Heiken Program and about a mother whose three-month-old son was diagnosed as functionally blind with CVI and was told by his doctor that there was nothing anyone could do to change that.

As my term as Chairman of the Board draws to a close, I want to thank our dedicated Board Directors, excellent leadership team, guided by the vision of CEO Virginia Jacko, and our outstanding professional staff. It is my pleasure to welcome Steven Solomon as incoming Board Chair. We are grateful and excited to have him bring his unique talents, expertise and perspective to the work of Miami Lighthouse in order to further our vision that every blind and visually impaired person has the opportunity to achieve their fullest potential.

From all of us who work to promote the mission of Miami Lighthouse to create independence and a better life for people with blindness and visual impairment, we extend our deepest thanks to you, our donors. As we celebrate the past and look to the future we count on your ongoing support.

## **Creating a CVI Conscious Community**

We were honored and excited to host Christine Roman-Lantzy, PhD, a leading expert in cortical visual impairment (CVI), developer of The CVI Range, and director of the Pediatric VIEW Program at The Children's Home & Lemieux Family Center, for a full-day workshop at Miami Lighthouse on May 17th. With over 30 years of experience working with children with CVI, Dr. Roman-Lantzy's lectures, workshops and multiple texts on the assessment and intervention methods for children with CVI are internationally acclaimed.

Dr. Christine Roman-Lantzy's, "Creating a CVI-Conscious Community" focused on the implementation of her infant screening protocol for infants at high-risk for CVI, structured educational intervention methods in the classroom and at home, social interaction skill-building for children with CVI, orientation and mobility skills, and best practices for collaborating across the whole team of educators, therapists, and parents when working with a child with CVI.

The workshop was funded by our The Children's Trust Innovation Grant to facilitate communitywide events for educational and health professionals, service providers, and community partners to increase awareness of CVI. Our 39 participants included representatives from neuro-ophthalmology at Bascom Palmer Eye Institute, optometrists from Nova Southeastern University and Miami-Dade, educators and service providers from Miami-Dade County Public Schools, representatives from University of Florida's Deafblind Project, parents, Miami Lighthouse Academy teachers, TVIs, professionals and staff.

## Miami Lighthouse Featured in Exceptional Parent Magazine


"Diversity and Inclusion Prepare Everyone for the Real World" by CEO Virginia Jacko appeared in the August 2023 issue of *Exceptional Parent Magazine*. The article talks about the importance of enrolling a visually impaired child in an inclusive environment for higher academic achievement, increased self-esteem, more social interactions within the classroom and a better understanding of diverse abilities.

"Seven years ago, we opened the Miami Lighthouse Academy, an inclusive learning environment for early learners ages one through four, with and without vision impairments, to ensure that children thrive together and form lasting connections and friendships," writes CEO Jacko. "A study from the University of Miami indicates that our classes are above national averages in

the areas of emotional support, classroom organization, and instructional support for both our toddlers' and Pre-K programs. When our visually impaired students graduate from our second grade they more easily adapt to mainstream public schools."



An article authored by CEO Virginia Jacko entitled "What to Know about CVI: The Leading Cause of Visual Impairment in Kids," appeared in the March 2023 issue of *Exceptional Parent Magazine*. It featured Lorenzo, one of our Miami Lighthouse Academy second grade graduates who entered our public school system reading at grade level despite at age three months his physician's hopeless prognosis. Lorenzo is one of thousands of children across the United States with Cortical Vision Impairment (CVI), a condition that affects approximately one third of children with visual impairment. Despite being told that there was no cure for her son's condition, Lorenzo's mother was determined to get help. She brought him to Miami Lighthouse where he joined our inclusive preschool program and began CVI educational intervention. Now as an elementary school student, Lorenzo is reading adapted text at grade level with

appropriate spacing between words and lines to reduce complexity. Lorenzo's story is a testament to the power of early diagnosis and intervention, two things that are critical when it comes to children with CVI.

#### **Art and Music**


Our artistic clients, despite their vision loss, continue to receive recognition. Their works have been chosen for juried art exhibitions and have won awards at state, national and international art competitions.

# Miami Lighthouse's Florida Heiken Program Makes a Lasting Impact on the Lives of Children throughout the State

A Lafayette County Public Schools Student Received His First Pair of Prescription Glasses from Our Florida Heiken Children's Vision Program

During the 2022-2023 school year our Florida Heiken Children's Vision Program provided more than 18,000 schoolchildren throughout the State of Florida a comprehensive eye exam and nearly 12,000 received prescription glasses. 'Oh. I can see better now!"

Ms. Pearson says, "Joey received his very first eyeglasses from the Florida Heiken Program. The glasses were a very strong prescription, and the little boy was over the top with joy when he received them. One of the first things he did when he returned to the classroom was to ask his teacher what the spots on her face were. The spots were actually freckles, and Joey had never seen anything like them before. He also told several teachers that he thought they looked very skinny. I told him that was because they were all blurry blobs before his new glasses allowed him to actually see details.

Joey was so busy looking at everything with his wonderful new eyeglasses that he kept asking questions about what different things actually were. I decided to call his mother who was awed to hear what was happening. She remarked that her son had never worn glasses before, even though his doctor had mentioned that she should have his eyes checked. She had never done so, although she had noticed her son always placed his face very close to anything he was trying to look at.

In closing, Ms. Pearson remarked that Joey's story had her crying at the wonder of the little boy's incredible new eyesight thanks to the prescription glasses provided him by our Florida Heiken Program. "Believe me, I wasn't the only one crying in that room," she said. "It was a very moving day for all of us."



On August 31st Dr. Eduardo Alfonso, Professor and Chairman at Bascom Palmer Eye Institute, and Miami Lighthouse CEO Virginia Jacko welcomed Bascom Palmer faculty, fellows, and residents to our annual Miami Lighthouse collaborative dinner, which reinforces the longstanding, strong relationship between the two institutions.


