Miami Lighthouse Celebrates 85th Anniversary at the Historic Biltmore Hotel

Three hundred of Miami's leading philanthropists and elected officials spent an extraordinary evening on Saturday, January 28th, enjoying cocktails provided by Bacardi and wine by El Carajo. Presenting sponsor for the evening was Northern Trust. The co-chairs of the celebration, Mr. and Mrs. Ramón Casas and Mr. and Mrs. Louis Nostro, were announced this past March at the Northern Trust pre-gala event. Entertainment was provided by Miami Lighthouse's nationally recognized student and instructor instrumentalists and vocalists.

The evening, commemorating our 85th year, highlighted Miami Lighthouse's beginning in 1931 during an era when Helen Keller challenged the Lions to become "knights for the blind in the crusade against darkness." In recognition of that important moment, CEO Virginia Jacko referred to an original letter from Helen Keller pertaining to a garden party that she attended. Ms. Jacko explained that funds were raised in those early years by holding garden parties attended by prominent Miamians such as Mrs. Charles Brickell, Mrs. Freeman Burdine, Marjorie Stoneman Douglas, Mrs. Charles Deering, Mrs. Harvey Firestone and Mrs. Hugh Matheson. The legacy of those formative years continues today, noted CEO Jacko, who recognized those in attendance as truly "knights for the blind."



Progress on Our Lighthouse Learning Center for Children™

In collaboration with Miami-Dade County Public Schools and the Early Learning Coalition we launched our inclusion Pre-K program for 15 three- and four-year-old visually impaired children and their sighted peers this fall. Using the evidence-based HighScope Curriculum, blind or visually impaired

students are supported in a print/braille rich environment where accommodations are implemented by onsite licensed instructors trained in visual disabilities and/or certified orientation and mobility specialists. With the completion of our Lighthouse Learning Center for Children™, our pre-kindergarten will expand this coming fall to 30 children and daily services will be offered for 10 toddlers.

The groundbreaking ceremony for our new Lighthouse Learning Center for Children™ was held on August 3, 2016; the building will be topped off on April 7, 2017; and the building dedication ceremony will be held on August 16, 2017 with classes slated to begin on August 21. In addition, Ms. Chica was trained in implementing the evidence-based HighScope Curriculum.

The system clips on to the wearer's glasses with a small magnet and uses a bone-conduction speaker to offer clear speech as it reads aloud the words or object pointed to by the user. 


