OUR FLORIDA HEIKEN CHILDREN'S VISION PROGRAM, LLC TAKES PRIMARY EYE HEALTH CARE DIRECTLY TO FLORIDA SCHOOLCHILDREN TARGETING TITLE ONE SCHOOLS USING OUR FOUR MOBILE EYE CARE UNITS THAT VISIT OVER 500 SCHOOLS ANNUALLY AS WELL AS PROVIDING VOUCHERS IN COLLABORATION WITH OUR NETWORK OF 1,200 OPTOMETRISTS. THE TWO INDEPENDENT LIVING PROGRAMS ENROLLED 230 CLIENTS. WE CONTINUED PROVIDING INSTRUCTION VIA ONLINE APPLICATIONS SUCH AS ZOOM AND MICROSOFT TEAMS AS WELL AS ON-CAMPUS LEARNING. OUR BRIGHT BEACONS PROGRAM IS FOR CHILDREN AGES 6-12. WE OFFER BOTH YEAR-ROUND INSTRUCTION AND AN INTENSIVE EIGHT-WEEK SUMMER CAMP. ONE HUNDRED TWENTY ONE STUDENTS WERE ENROLLED IN THESE PROGRAMS.
