On Saturday, January 25, 2020, Miami Lighthouse marked the historic milestone of 90 years of service to the blind and visually impaired at a celebratory, black-tie gala presented by Northern Trust at Coral Gables historic Biltmore Hotel. The event highlighted the organization's founders Dolly Gamble, the Miami Lions and Rotary Clubs, and Shutts & Bowen, the law firm that drew up Miami Lighthouse's Articles of Incorporation. Elite "Lighthouse Keepers" and "90th Anniversary Jubilarians" donors were also recognized.

The evening's festivities began with a champagne toast and wine provided by El Carajo and cocktails by Bacardí and a silent auction overlooking the Biltmore golf course. #### Chairman's Letter

Dear Friends of Miami Lighthouse,

What an incredible beginning to Miami Lighthouse's 90th anniversary festivities! A jubilant crowd of nearly 350 supporters gathered at the Biltmore Hotel in Coral Gables on Saturday evening, January 25 to celebrate nine decades of service to the blind and visually impaired. Simultaneously, with recognition of our many accomplishments, our guests were firmly focused on the future and sustaining the growing role of Miami Lighthouse throughout Florida and beyond.

When Dolly Gamble, the charismatic teacher of the blind, first envisioned a haven for Miami's visually impaired residents back in 1928, neither she nor her supporters could have imagined the role and broad scope of services that Miami Lighthouse would eventually provide. Today, on the original site of the tiny bungalow that housed Ms. Gamble's Florida Association of Workers for the Blind stands Miami Lighthouse's 120,000-square-foot facility. The four-story building is abuzz with activities on a daily basis, annually serving more than 25,000 program participants from birth through their senior years.

While celebrating 90 years of empowering the visually impaired, Miami Lighthouse finds itself at a crossroads. Our organization is already recognized as one of the nation's foremost and most innovative institutions serving the needs of the blind. Yet we are aware that there is so much more left to be done, particularly for visually impaired children. Thus, we have mounted our "Light the Way" campaign to expand our Miami Lighthouse Learning Center for Children™ to accommodate its rapidly growing enrollment of preschool and kindergarten students. Additionally, we are experiencing increased demand for many other existing and future programs. To participate in this matching challenge, just return the envelope enclosed with this newsletter.

Miami Lighthouse is grateful to all of its benefactors, volunteers and staff for empowering our organization to reach this milestone anniversary. We also appreciate the role you play in energizing Miami Lighthouse to reach its full potential. Together we make a difference.

#### LIGHT THE WAY CHALLENGE

The "Light the Way" campaign is a one-for-one matching challenge to raise \$9 million in support of our Miami Lighthouse Learning Center for Children™ expansion. We raised \$1.5 million in 2019 toward the Spencer \$4.5 million "Light the Way" match. Now in 2020, we need to raise \$2 million and by June 2021 the remaining \$1 million before our August 2021 Ribbon Cutting for our classroom expansion.

We are one-of-a-kind and have built something special. Miami Lighthouse has the first fully inclusive childhood program in the country for children with and without visual impairments. Our Lighthouse Learning Center has been so successful since first opening its doors in 2016 that we've run out of classrooms to meet the growing demand. Additional space is vital for Miami Lighthouse to meet our current needs and expand access to our services for our growing enrollment.

#### WILDFLOWER FOUNDATION MATCHING CHALLENGE FOR ART AND MUSIC

The Wildflower Foundation challenge supports year-round music and tactile arts programs at Miami Lighthouse to improve employment opportunities and provide social support for our visually impaired clients.

# Technology in the Service of the Blind and Visually Impaired MIA Launches Aira Service for Visually Impaired Passengers

On October 25th, 2019, in recognition of Blindness Awareness Month, representatives from Miami International Airport (MIA), Aira, and the Miami Lighthouse for the Blind and Visually Impaired announced MIA's addition to the Aira Airport Network, a free mobile service that allows blind or low-vision travelers to receive up-to-the minute flight information, navigate security, use self-service kiosks, find restaurants and services, identify baggage, and more. Our Orientation and Mobility Program at Miami Lighthouse teaches blind and visually impaired travelers how to safely use technology like the Aira app, and we



were on hand to applaud the partnership between Aira and MIA, which puts them at the forefront of assisting those who are blind and visually impaired. WSVN-7 covered the launch.

On October 29th, 2019, Miami Lighthouse hosted a technology demonstration day with OrCam and a ceremony awarding a new OrCam MyEye device to Henry Arguello. Henry, who is visually impaired, will be able to use his OrCam for his job at Home Depot, which involves reading product labels, reading information and invoices on his phone and other screens, checking packaging slips, locating inventory boxes and much more. Henry graduated from Miami Lighthouse's Job Readiness Program, and the OrCam will allow him greater personal independence and will enable him to perform his job more efficiently.

#### Virginia Jacko Honored with Global Award

Virginia Jacko, President and CEO, was one of 10 global leaders honored at the 2019 Henry Viscardi Achievement Awards in New York City. Viscardi was a disabilities advocate who served as an advisor to eight presidents from Franklin D. Roosevelt to Jimmy Carter and implemented groundbreaking employment and education programs that continue to improve the quality of life for people with disabilities. Leaders were selected for their extraordinary societal contributions and for having a profound impact on improving the quality of life of people in their countries and around the world. 


## Two New Books: Shine Your Light and Shine More Light



# Fifteen Years of Exponential Growth in Service to the Blind and Visually Impaired

A recent review of participation in Miami Lighthouse's programs reveals exponential growth in the organization's capacity over the course of the last 15 years. From a starting point of 487 program participants in 2004 (387 adults and 100 children), the organization's growth in capacity and increased program offerings has yielded a fifty-fold increase in the number of program participants served to a high of 24,800 participants, including 9,072 adults and 15,728 children in 2019. Demand for our first-rate programs continues to be high, and through our matching challenges and campaigns, we are working to increase capacity even further in the coming years.
